4. Release, waive discharge and covenant not to sue the facility (Aliber Soccer Complex) and host (F.C. Des Moines), their affiliated clubs (including but not limited to Soccer West Soccer Club), their respective administrators, directors, agents, coaches, employees; other participants, sponsoring agencies, advertisers, and any owners and leasers of premises used for the events; all of which are hereinafter referred to as "releases," from demands, losses, or damages on account of any injury, including death or damage of property.
